

**BVB:** Transparent Financial Planning Reduces Workload for Controlling and Strengthens Business

Almost 130 million people travel annually with Swiss public transport company, Basler Verkehrs-Betriebe. BVB's buses and trams cover the Basel area, reaching into both German and French border regions. This requires extensive planning. The tram and bus routes themselves, as well as long-term construction projects and investments must be planned meticulously. By 2027, for example, every bus is to be electric. All projects are financed with public funds, with multiple stakeholders requiring precise, easily-verifiable financial figures to inform their decision-making. But BVB's reporting system was too complex to provide these insights quickly.

As part of a comprehensive business transformation, BVB wanted to become more transparent and revamp processes across all business functions. This included **rethinking the planning process:** In the future, all single and multi-year plans will be made in consultation with multiple departments beyond controlling – a true paradigm shift.
